Committee Report

2018 has been a busy year for the Committee with changes to membership, governance and lease negotiations with North Metropolitan Health Service (NMHS).

The Social Club Committee was advised this year that a lease would need to be entered into with the NMHS for the gym, bar and Social Club office spaces. While NMHS have supported the maintenance of a gym for members on site by offering a very affordable lease agreement, they were unable to offer the same for the R Block bar area. As such, we were asked to sign a commercial lease agreement with NMHS. The Social Club is a member-funded organisation and we are not able to pay this lease while maintaining sufficient funds to remain a going concern. As such, it's with a heavy heart that the Social Club Committee has made the decision to surrender the R Block Bar, kitchen, office and storage spaces. The bar will cease operation on the 21 December 2018. Despite this sad news, the Committee is excited about the opportunity to reconfigure the club as a Health and Wellnessfocused association. With this change we will be able to invest significantly more into maintaining and improving the gym, adding to class and the events schedule

Social Club President, Peter Gibbons has resigned from the Committee. The Committee would like to thank, President Peter Gibbons for his tireless work and commitment to the Social Club first as a social club committee member in 2010-2011 and then as President of the Social Club from 2012. Peter has led many significant improvements in his 7 years as President such as; introducing a range of administrative and governance processes for the management of the club; purchasing new gym equipment; increasing access to personal trainers and fitness classes, and upgrading the club rooms and bar, even going so far as to build the stage. It is no exaggeration to say that there likely would not be a Social Club without Peter's efforts and enthusiasm and we would all be poorer for it. Peter has had a profound impact upon the Club, the social environment of this hospital and on the lives of individual members. We have been incredibly lucky to have him and while we will never be able to replace him, we will do what we can to maintain his legacy and lead by his example.

The Administrative Office

The Social Club employs three part-time Administrative Staff who manage the day to day functions of the Social Club. 2018 saw a complete changeover of our Administrative Team and we welcomed Alison, Alexis and Monique to the club. The team has been hard a work in 2018 learning the systems and process and making the Social Club the best it can be.

The Social Club office is a buzz of activity with members dropping in regularly to access services, make purchases or raise queries. In addition to providing terrific customer service to our members Alison, Alexis and Monique spend much of their time planning events, management memberships, organising classes and answering online and phone queries. They are essential to the smooth running of the Social Club and we thank them for their hard work.

Charlies Bar

Attendance by both members and non-members has increased steadily in recent years, and though attendance did not increase in 2018 it was consistent.

Charlies Bar ceased operation on 21 December 2018. This decision was made by the Committee after several months of financial review, consideration and discussion with the NMHS. Members can be assured that the decision was not made lightly and due consideration was given prior to decision. In 2018 the Social Club was asked to sign a commercial lease agreement with NMHS to retain the Bar/Club rooms. The Social Club is a member-funded organisation and we are not able to pay this lease while maintaining sufficient funds to operate.

Finances

It was another difficult and busy financial year for the Social Club. The management of finances, records and reporting is a considerable amount of work for the Committee and Treasurer. The committee continues to ensure careful management and budgeting to ensure past debt is paid off as quickly as possible and membership fees are used effectively and transparently managed.

Financial record and reporting is maintained in financial software, Xero, and ensures tracking and reporting of sales, purchases and payroll. Ordering and stock control has been tracked and reported through the sale system, Clubware.

An annual external finance review was recently conducted by Avant Edge Consulting. Several recommendations were made by the auditor to improve processes and ensure robust records management. The committee has prioritised these recommendations and is working to ensure all recommendations are implemented by early 2019.
